The tryout fee for rep teams is \$60. There is also a rep fee of \$150 for any player who makes the rep team. Players who register for tryouts will have the rate honored to pay when the child was registered. I.e. If someone registers for Tryouts in the Early Bird stage they would pay the early bird rate, plus the rep fee if they made the team.

### **Tryouts/Evaluations/Teams**

Rep teams will have their 4 pre-evaluation skates 1hr timeslot starting the first week of September. Exact dates and times TBD later. Tryouts will then commence afterwards 2<sup>nd</sup> week of September with 4 ice times per rep team. 1 x 1hr ice time, 2 x 1.5hr ice time and 1 exhibition game if the coach chooses to do so. Regular practice schedule to begin the week of September 15<sup>th</sup> for the whole association. Local teams will have 2 x 1hr practices per week and the Rep teams will have 2 x 1.5hr practices per week. For U6/7 next year, recommended to divide the ice up for the U6 on one end and the U7 on the other end depending on number of players/coaches.
